VICTIM WAS AT END OF BRIDGE IN COMPANY OF
COUSIN - NOELLE MERLE, AGE EIGHT
WHEN A MAN APPEARED OUT OF WOODS
AND TOLD GIRLS HIS BROTHER WAS HURT AND
WOULD THEY HELP HIM.

WHEN THEY APPROACHED HIM HE HAD A KNIFE
AND FORCED THEM INTO WOODS AWAY FROM
ROAD BY PUTTING KNIFE TO SIDE OF LAURIE
ANN AND THREATENING THEM.

WHEN THEY REACHED A SMALL CLEARING, HE TOLD
NOELLE TO SQUAT DOWN. AND ~~FORCED~~ WHEN SHE
ASKED HIM WHAT HE WAS GOING TO DO

he replied that he was going to fool around with her sister.

He then forced Laurie Ann to remove her clothing from the waist down and told her to lay down. He then removed his clothes from the waist down and proceeded to rape her.

STATEMENT FROM MOTHER

TAKEN AT APPROX 2030 HRS IN CONFERENCE ROOM
5 AUG 81

MOTHER STATED THAT WHEN GIRLS ARRIVED HOME SHE COULD SEE SOMETHING WAS WRONG WHEN SHE QUESTIONED LAURIE ANN. CHILD WAS RELUCTANT TO TELL HER WHAT HAD HAPPENED WHEN SHE FINALLY GOT CHILD TO TELL HER WHAT HAD HAPPENED, SHE EXAMINED GIRL AND NOTICED THAT THERE WAS VAGINAL BLEEDING. SHE THEN CALLED HER HUSBAND WHO HAD JUST ARRIVED HOME; THEY THEN STARTED TO TAKE VICTIM & COUSIN TO HOSPITAL

A SHORT DISTANCE FROM HOME THEY OBSERVED A BROWN CAR WITH A MAN DRIVING THAT THE GIRLS SAID LOOKED LIKE THE ASSAILANT. THEY THEN FOLLOWED CAR TO WIENER RD WHERE CAR TURNED INTO DRIVE WAY WHEN THE MAN GOT OUT OF CAR & BOTH GIRLS SAID IT WAS NOT THE RIGHT MAN THEY THEN PROCEEDED TO HOSPITAL.

RAINBOW CONTROL WAS CALLED FROM THE HOSPITAL EMERGENCY ROOM BY STAFF. RAINBOW CONTROL THEN CALLED OFFICER TOM DONALDSON BADGE 68A. AND TOLD ^{HIM} TO CALL CONTROL CENTER WHERE HE WAS PATCHED THRU TO HOSPITAL EMERGENCY AND REQUESTED TO COME TO HOSPITAL.

MOTHER AND FATHER STATED THAT IF ASSAILANT WAS CAUGHT, THEY WOULD DEFINITELY PROSECUTE

WHEN ASKED IF MAN HAD DISTINGUISHING MARKS
OR SCARS - SHE SAID THAT SHE NOTICED
A LIGHT GREEN MARK ON HIS LEFT ~~ARM~~ ARM
ABOVE ELBOW

WHEN ASKED IF MARK WAS TATOO SHE SAID
IT COULD BE , BUT WASN'T SURE . IT COULD BE
PAINT SMEAR OR SOMETHING ELSE

When I ASKED HER IF THERE WAS ANYTHING ELSE SHE COULD REMEMBER ABOUT INCIDENT SHE STATED THAT AT ONE TIME HE PUT HIS HAND OVER HER MOUTH.

When I ASKED HER WHAT HIS HAND SMELLED LIKE, SHE SAID GREASE OR OIL

I ASKED HER WHAT COLOR THE MAN'S EYES WERE - SHE ~~SAID~~ SAID DARK BROWN AND HAD DARK ~~HAIR~~ EYE BROWS -(HEAVY)

ASKED MOTHER IF SHE HAD WASHED HER, MOTHER SAID NO.

When ASKED WHAT CONDITION SHE WAS IN REGARD TO APPEARANCE - SHE SAID SHE WAS DIRTY - BLACK-LIKE FROM HUMUS

TOLD BY NURSE ATTENDING HER THAT THERE WAS VAGINAL PENETRATION
~~NO OTHER~~ NO PER OSS OR PER ANUS

ASKED MOTHER WHAT CONDITION LAURIE WAS IN. BEFORE LAURIE WAS CALLED TO ROOM. MOTHER STATED THAT SHE WAS STARTING TO FEEL EFFECTS OF THE INCIDENT.

SHE SAID SHE THOUGHT SHE WAS OKAY THAT MORNING - BUT LATER WHEN SHE DECIDED TO TAKE GIRLS SHOPPING THAT WHEN THEY GOT AROUND PEOPLE SHE COULD SEE THAT IT WAS BOTHERING HER & SHE STARTED TO CRY. SHE BROUGHT THEM HOME.

When ASKED BY FRED ABOUT COLOR
she SAID DARK - NOELLE SAID IT WAS

Then LAURIE SAID IT WAS A FUNNY COLOR

MOTHER AND FATHER AND LAURIE AGAIN STATED
They would PROSECUTE

ALSO WHEN ASKED LAURIE ABOUT HIS COMPLEXION
& SKIN she SAID HE WAS TANNED BUT NOT
REAL DARK & HIS SKIN ON HIS CHEEKS WAS
ROUGH.
